

SEND Information Report

These pages set out information about our provision for children and young people with special educational needs (SEND). They are updated annually.

About our school

Dry Sandford Primary School provides for children and young people with a wide range of special educational needs including those with:

- Communication and interaction needs;
this includes children who have speech language and communication difficulties including autistic spectrum conditions.
- Cognition and Learning needs;
this includes children who have learning difficulties and specific learning difficulties like dyslexia, dyspraxia and dyscalculia.
- Social, Emotional and Mental Health needs
- Sensory and/or Physical needs;
this includes children who have visual or hearing needs, or a physical disability that affects their learning

We are a mainstream school.

How do we identify and give extra help to children and young people with SEND?

The school uses Oxfordshire County Council's guidance 'Identifying and supporting Special Educational Needs in Oxfordshire schools and settings'.

The guidance sets out:

- How we identify if a child or young person has a special educational need.
- How we assess children and plan for their special educational needs, and how we adapt our teaching.
- Ways in which we can adapt our school environment to meet each child's needs
- How we review progress and agree outcomes and involve you and your child in this.

How do we work with parents and children/young people?

We will always contact parents if we have a concern that a child or young person may have a special educational need.

We work closely with children and young people with SEND and their parents to agree outcomes and how we will all work towards these, and then to review progress. We Set targets in November each year and then review these with parents in March, July and then with a final review in the following November when we set up new targets.

Adapting the curriculum

We offer a broad and balanced curriculum for all children and young people including those with SEND. Details are published on the school website. The way we adapt this for children with SEND and disabled children will be set out in the School Accessibility Plan. which is currently under development

We use intervention programmes including Project X 'Code', New Reading and Thinking, precision teaching to support the development of language and literacy skills.

We use 'Doodlemaths' to develop maths skills. Children with Social, Emotional and Mental Health difficulties can access support through our Emotional Literacy Support Assistants. We also have a Nurture Room which is accessible on a timetable

What expertise can we offer?

Our SENDco is also one of our KS2 teachers who works closely with the staff team and has recently qualified as a SENDco

Our SNA holds the National Award for SEND co-ordination and has a Masters degree in Education.

All staff have basic awareness level training in Autism, Attachment, restorative practices. All staff are 'Team Teach' trained and most have received training from Mulberry bush school on Behaviour as communication and have all had stage 1 and 2 training from Betsy DeThierry.

We have two members of staff with a Certificate of Therapeutic Mentoring.

We have staff who have received enhanced training in restorative practices.

There are also members of staff who have trained at a specialist level in support children with Mental Health needs – Mental Health first aid, Drawing and Talking therapy, Lego-based therapy, water and sand play therapy.

Teaching assistants are trained to support the particular needs of the children they work with.

We also have access to a range of specialist support services including:
Educational Psychology

SENDSS, who support children with communication and language, sensory needs and physical needs
Child and Adolescent Mental Health Services (CAMHS)
Oxfordshire School Inclusion Team
Therapy services – including BdT
Early Intervention
Children’s Social Care
Mulberry Bush school outreach

We always discuss the involvement of specialist SEND services with parents first.

We also work with other services and organisations that are involved with a family, with the family’s permission.

How do we know if SEND provision is effective?

The progress of all children/young people is tracked throughout the school through Microsoft Teams

In addition for children/young people with SEND we regularly review progress towards agreed outcomes assessing whether the support that’s been in place has made a difference and what we need to do next. We evaluate this progress against age related expectations.

When we run special intervention programmes for groups of children we assess how successful they have been and use that information to decide on how best to run them in the future.

The governing body evaluate the success of the education that is provided for pupils with SEND by monitoring books, learning walks and monitoring visits. The named Governor for SEND is Mrs Gillian Gillett

How are children and young people with SEND helped to access activities outside of the classroom?

All children and young people are included in activities and trips following risk assessments where needed and in accordance with duties under the Equalities Act 2010. We talk to parents and young people when planning trips so that everyone is clear about what will happen.

What do we do to support the wellbeing of children/young people with SEND?

All children have the opportunity to share their views through their school council representatives and regular 'pupil voice' meetings with the Head Teacher.

We listen to the views of children/young people with SEND for example through the use of '3 houses' or other appropriate means and they contribute to their 'Pupil profile'.

We take bullying very seriously. We help to prevent bullying of children/young people with SEND through our use of the restorative approach.

Joining the school and moving on

We encourage all new children to visit the school before starting. For children/young people with SEND we offer additional visits, phased transition, and where appropriate meetings including any professionals involved with the child.

We begin to prepare young people for transition into the next stage of their education or training by liaising closely with the schools concerned, arranging additional visits, SEND handovers and meetings with other professionals.
